In this Privacy Policy, MARINERGY RENEWABLE ENERGY CONSTRUCTION AND TRADE INC. <http://www.marinergy.com.tr/> website ("Site") operated by the website ("Site") / shared with MARINERGY RENEWABLE ENERGY CONSTRUCTION AND TRADE INC. by the Site / Mobile application users / members / visitors ("Data Owner") during the operation of the mobile application or MARINERGY RENEWABLE ENERGY CONSTRUCTION AND TRADE INC., the Data Owner The terms and conditions regarding the use of personal data generated during the use of the site are included.

What Data Are We Processing?

Your personal data processed by MARINERGY RENEWABLE ENERGY CONSTRUCTION AND TRADE INC. has been categorized in accordance with the Personal Data Protection Law (Law) as stated below. Unless otherwise explicitly stated, the term "personal data" will cover the following information within the scope of the terms and conditions provided under this Privacy Policy.

- **Location Information:** Specific or approximate location information about your location, such as GPS data, that we have obtained during your use of MARINERGY RENEWABLE ENERGY CONSTRUCTION AND TRADE INC.'s services.
- **Transaction Security Information:** Log in credential information, password information
- **Marketing Information:** The reports and evaluations showing your habits and likes, targeting information, cookie records, etc.
- **Request / Complaint Management Information:** Requests and complaints you made on the Site and your comments shared on the Site.
- **Risk Management Information:** The data whose IP address is anonymized within the framework of Articles 3 and 7 of the Law will not be considered as personal data in accordance with the provisions of the aforementioned law and the processing activities related to this data will be carried out without being bound by the provisions of this Privacy Policy. What is the Purpose of Use of Your Data?

Your personal data are shared with MARINERGY RENEWABLE ENERGY CONSTRUCTION AND TRADE INC., so that you can benefit from the Site and the services provided through the Site or the Mobile application, make your membership registration to the Site, update the membership registration, improve the services offered by MARINERGY RENEWABLE ENERGY CONSTRUCTION AND TRADE INC. and on the Site, new services are introduced and accordingly such personal data can be processed in order to carry out commercial activities, to determine and implement commercial and business strategies, to ensure the legal and commercial security of MARINERGY RENEWABLE ENERGY CONSTRUCTION AND TRADE INC. and the persons who are in business relations with MARINERGY RENEWABLE ENERGY CONSTRUCTION AND TRADE INC. and to provide you with the necessary information in this context and to fulfill the obligations arising from the nature of these activities. Your personal data can also be used for database creation and market research purposes. - It is mandatory for MARINERGY RENEWABLE ENERGY CONSTRUCTION AND TRADE INC., to fulfill its legal obligations,
- It has been made public by the Data Owner himself,

Most of the browsers are originally designed to accept the technical communication file, but users can always change the browser settings so that the technical communication file does not arrive or the technical communication file is sent.

Who Can Access Your Data?

MARINERGY RENEWABLE ENERGY CONSTRUCTION AND TRADE INC. may transfer your personal data and new data obtained using this personal data to restaurants in order to achieve the purposes specified under this Privacy Policy, limited to the provision of such services. Anonymous or limited data transfer can be made to our business partners and suppliers and third parties from whose services they benefit, and in these cases, separate approval can be obtained.
